MINUTES OF STATE MEETING NOVEMBER 14, 1976
HERMISTON, OREGON - EASTERN OREGON AREA - COLUMBIA GRANGE

The meeting was called to order at 10:05 by CHUCK McDONALD, President. The invocation was given by BERNICE GRUCHELLA and the Pledge of Allegiance to the flag was lead by GRAHAM WOOD.

Roll call of officers and areas was read by MARGE POUND, Recording Secretary. JOHN VANLANDINGHAM, Membership Chairman, and AL BOYER, South Coast Area Representative were absent. Also absent were WAYNE and GEORGIA PUCKETT, our Good Will Ambassadors. Present and substituting for LUTHER CHRISENBERRY of the Umpqua Area, was BYRON STEWART.

MOTION TO
APPROVE
MINUTES

AL WESTPHAL, First Vice President, moved that the reading of the minutes of the last meeting be dispensed with since all officers and delegates had received a copy. The motion was seconded and passed. There were no corrections or additions to the minutes.

TREASURER'S REPORT - GLEN PFEFFERKORN. The treasurer read the report covering the period from August 22 to November 14, 1976. A copy of said report is attached hereto and by reference made a part hereof. The Recording Secretary asked that all Officers and Delegates retain the copy of this report which they were given so that they could attach it to the copy of their minutes, in order to save expense of recopying the report.

OFFICER REPORTS

AL WESTPHAL (Fran) stated that he had nothing to report at this time, but would have a report under Old Business. He did commend the dancers of the Eastern Oregon Area for good halls, good callers, good food, good dancers and a good time!

RAY MURRAY (Dorothy) 2nd Vice President. He had no formal report, but did ask that any of the areas that might have extra directories call him as he is getting calls from areas that are running short. He is attempting to determine how many directories are available so that he can get them to the people who need them. He has none left over.

MARGE POUND (Harold) Recording Secretary. Called attention of the delegates to the bulletin board on the wall and asked delegates who had announcements of special dances in their area to post the information on the Board during the recess in the meeting.

MARY PUTER (Coy) Corresponding Secretary. No report.

The membership chairman was absent, however, a report was given at this time by JACK BRINSON (Ilene). Jack reported that there is a new club called the APPLGATERS in the Rogue-Sis-Q Area at Grants Pass. They dance on the 4th Thursday of each month. They have 32 active members at the present time. He stated that the reason that the reason JOHN and GERI VANLANDINGHAM were not present was due to the fact that their club had its Birthday Dance the previous Sat. night.

BUDDY RANDALL (Nancy) Parliamentarian. Buddy reported that a problem had come up at the last meeting and that he hoped that all the delegates were prepared to vote on the question of changing the meetings back to three plus two. He stated that President Chuck had written regarding this to all of the area delegates. These would be three quarterly meetings, plus a meeting at the Winter Festival and a meeting at the State Festival, three would be paid for by the State for

the Officers and Delegates, if we have money, and the Winter and Summer Festivals would be at officer/delegate's own expense. President Chuck had also appointed a Committee consisting of the RANDALLS, the LAUDERDALES and the BARNES to bring the Practices and Procedures up to date. Buddy stated that this would be done immediately after this meeting, and would be available at the Winter Festival meeting. The Secretary was asked to call the roll in order to determine delegates position on the question of the number of meetings. The Roll Call vote was unanimous. President Chuck stated that the times on the three meetings would be flexible, they will not be a set meeting. Therefore, the next meeting will be at the Winter Festival coming up January 29th and 30th. The meeting will be on the 30th (Sunday) 12 to 1:30 in the round building. It will be no longer than an hour and a half and will be over at 1:30 so you can either go back to dancing or head on home.

The question was asked by SANDI FOGELSON, Emerald Empire, if the meeting at the Winter Festival would be considered the Emerald Empire's turn as host area. The response to this question was that it would not, and that the Emerald Empire would be responsible for hosting the following State Meeting, as the Winter and Summer meetings at the festivals would be special meetings and would not fall under the hosting schedule.

GRAHAM WOOD - (Nedra) Past President. Graham stated that he was now wearing three hats, that of the Fairview Committee, the Nominating Committee and the Advisory Committee to the Summer Festival. Since the Fairview report would be given later by TOMMY THOMPSON, Graham spoke representing the Nominating Committee. He stated he left a blank for each delegate and it is hoped that each Area will come up with at least one prospective candidate. The Nominating Committee will meet at the Winter Festival to come up with next year's officers. Regarding the Summer Festivals, Graham stated that he felt that the small Areas should not oppose hosting them because they can call on people from all over the State to help. He stated he believed the entire State should be involved in these Festivals. He also stated that we could also use some of the fine callers we have around the state and incorporate them into our State Festivals a bit more.

JACK BRINSON (Ilene) State Reporter. Jack stated he had nothing to report except that SQUARE DANCE WEEK went over really good and that they were very satisfied. President Chuck mentioned at this time that there was a Proclamation of Square Dance Week which was signed by Governor Straub on display at the Head Table if anyone was interested in seeing it.

GEORGE GRIFFITH (Lorene) Historian. George stated that he would like the area delegates to pass on to their clubs that the Historians would like all the information they can get about special club activities, special dances going on in the areas, so that they can get them all together in the History Book. They would also like to be able to collect in one place all of the suggestions that the various clubs might have for creating more interest in square dancing and this information would be made available in the History Book so that anyone could refer to it for ideas.

ED WARMOTH (Mary) Publicity. Ed stated that for this meeting and for the new State President, that he sent stories about their being installed as President to several papers around the state. It appeared in the Journal and in the Register Guard in Eugene, and it appeared in the East Oregonian. He stated that there was a reporter covering the dance last night and that there should be some coverage in the local paper. Ed called attention to an article printed in the Capitol Journal in the Salem area (which he had had nothing to do

with) It was a tremendous article on square dancing complete with colored photos. He stated that they had sent the Capitol Journal a letter of appreciation and also reminded them that the Fairview Dance is held right in their back yard in April and that perhaps they could arrange some publicity on this dance for us. Ed referred to a recent article in the OFN regarding the possibility that there be a float that could be borrowed by various areas for use in local parades. Several clubs have done this on their own, however, it is Ed's idea that perhaps on a flat bed trailer a basic float could be built which people could borrow and further decorate to suit themselves. Ed mentioned the Publicity Planner Sheet. It has calendars for both 1976 and 1977 on it and Ed would like to get this filled with all the Area special dances, festivals, etc. He feels that he might be able to develop some stories on some of these special events and that it would also collect together in one place the key dances in the areas and prevent scheduling conflicts. He asked delegates to take some of these Publicity Planner Sheets back to their areas. Ed also gave us the news that "There is Good News in the White House" American Square Dance Magazine for October had a big write up on the fact that President-Elect Jimmy Carter and his wife are square dancers and were before he became governor, and that he had had dances in the Governor's Mansion in Atlanta. So, Ed says, there may be dances in Washington, D. C. Ed also stated that there is a Jimmy Carter of Jefferson City, Mo. who is a caller, so if you hear that Jimmy Carter is on the program, he advised to check this out more closely.

Ed stated that he had material on the National Convention coming up next June in Atlantic City. He has information on the flight package, including special tours. He also stated that he had a big box of the Centennial Bumper Stickers left.

MICK NOGLE (Ruth) OFN. Mick stated that Ruth stayed home as she had to attend a wedding - that she particularly likes to see people get married - especially men! Mick stated that when they found out that the Carters were square dancers that they sent them a copy of the OFN and an invitation to come out and dance at our State Festival. Mick stated that the month of October is the best month the magazine has had since Sunset Area has taken over the magazine - there were 20 new subscription. He stated that Three-Valley area and Lincoln-Tillamook area had both had subscription dances. The OFN crew is very well pleased.

JOHN NASHOLM (Bev) Chairman, Mid-Winter Festival. John reported that this will be held on the 29th & 30th of January, and that there will be a trail's end dance on Friday at Prairie Hall with Dan McCornack emceeing. Local callers will be used as well as those visiting as they sign in at the dance. John then reviewed the schedule of the activities on the week-end. John stated that there were added expenses due to price increases for services and facilities. Therefore, the admission this year is \$10.50 per couple for both days, \$6.00 per couple for Saturday only, and \$4.50 for Sunday only. There are the usual breakdowns for singles and teens as in the past. The Trail's End Dance on Friday night is \$3.00. He reported the following committees working: Gary Smith, Chmn. Publicity; Ivan Koehn, a caller in the Eugene area, is Chmn. of committee on sound. John stated that there will be two powerful sets in use this year and that sound will be improved. He called attention to the large poster that they have been carrying around the State thanks to the use of a camper. He also stated that he had with him some smaller posters and requested anyone who had a good spot to display one of the smaller ones to pick one up. A packet of information concerning hotels, motels, etc. was given to each Area delegate.

WARREN ENGBAHL (Florence) Chairman, Summer Festival. Warren introduced members of the Publicity Committee, TRUDI STEWART and BYRON STEWART. Warren gave a brief

rundown on the tentative program. The week end will start up with a "CRANK HER UP" Dance on Thursday night. There is a full program for the Teens as well as adults. For teens, in addition to dancing, there is a swimming party, a weiner roast, a Wild Life Safari tour as well as other events. For adults there is a full program of workshops, clinics, after parties and Safari tours, at special rates to all square dancers. Featured callers are Gaylon Shull, Bob Van Antwerp and Bill Peters. Rounds are by Anita and Leroy Stark. The evening dances will be on an all-wood outdoor floor which will accommodate 300 squares. The floor will be laid in front of the grandstand which can seat 5,000 spectators and resting square dancers. The entire week end will be at the Douglas County Fair Grounds and this facility offers parking for recreation vehicles; however there are no hookups, so vehicles should be self-contained. There are shower facilities in three different buildings on the grounds. Warren stated that the Motels in the area would prefer that registration be requested after the first of the year. He asked for names of persons who would be interested in participating in a modified style-show along with the "flivvers". He also asked anyone who has sound equipment available for rent to this festival to let him know. He also solicited any other ideas or suggestions. The committee would be glad to have them. He did state that as on the first State Festival 20 years ago, and the 10th Festival 10 years ago (both in Roseburg) the Committee has reserved a full moon and sunny skies. President Chuck asked Warren if he would rather have people work through Festival Committee for Motel reservations or make them directly with the Motel. It is preferred that they be made directly with the Motel was Warren's reply..

DELEGATE REPORTS

JERRY DALRYMPLE (Zanelle) - Central Oregon. Jerry stated that at the present time Central Oregon Area is quite involved with lessons. The classes are going very well and there are close to 100 couples involved in the lessons. Round Dancing is going well. There will be a Beginner's Jamboree December 12th.

JACK ROBERTS (Charlotte) - Eastern Oregon. Jack stated that the beginner's dances are the best they have ever had. He stated he would like to make a report on holding a State Festival, and stated that there are some of the dancers in his area that are in favor of it, but the majority are not. He stated, however, that during the delegates meeting preceding State meeting that there were incentives presented that might make it reasonable to take another look at the question. He stated that at the present time, he could not give a definite answer on this.

President Chuck at this time noted to the group that the Umpqua Area, which is hosting the current Summer Festival, only has three clubs, but that this did not seem to bother them.

JERRY FOGELSON -(Sandi) - Emerald Empire. Jerry also introduced their daughter, Anna, and the president of the Emerald Empire Area; RAY and JUNE NICHOLS. Jerry stated that while it had not come to a formal vote, that he had discussed the matter of hosting a Summer Festival with a cross-section of dancers and he felt that if it came to a vote, the area would be willing to do so.

DON CRAWFORD (Rosemary) - Interstate Highlanders. Don introduced ERV BLACK and his wife, GEN, callers for the K.C. SQUARES. Don stated that alot of people wonder how come Burney and Tulalake California are in the Area. This is because Northern California is rather blocked off from the rest of the State and this Area takes in clubs within a radius of 150 miles. Don stated that there is a new class at Merrill, Oregon and perhaps this will result in a new club there. To answer the Summer Festival question, the area stated "yes" they would be willing to do this.

President Chuck stated that it was very gratifying to see some of the areas coming around to an affirmative attitude toward the Summer Festivals, since there had been negative feelings for so long.

EARL AYRES (Charolette) Lincoln-Tillamook. Earl introduced the Toledo 49'ers caller, SAM SCOTT, and his wife, SHIRLEY. Earl reported on the Subscription Dance which resulted in 25 subscriptions. He stated that he had received no reaction on holding a Festival. The next area meeting is in February.

HAROLD BRESSLER (Faye) Mid-Willamette. He introduced VERNE and RUTH McKNIGHT who are from Mid-Willamette area. Most of the clubs are having beginner's classes and some of the clubs are reporting from 4 to 6 squares. He reported a Fall "Tune Up" dance on October 30th which was very successful with about 20 squares. One other item he reported was that the Mid-Willamette area would go ahead with a Summer Festival if chosen.

VERN MEYER (Mae) Portland Area. Vern also introduced Portland Area president, BOB INGLIS and his wife, DOROTHY, and former State President, TOMMY THOMPSON (IRENE). Vern stated that the beginner's classes in his area are larger than ever. He stated that dancers from the Portland area spent two weeks in September dancing at all the major shopping centers, and that this may be the reason for the large turnout. He stated that having just gone through one, the Portland area is not much interested in putting on another festival very soon, but they can offer help to other areas who are doing so. BOB INGLIS then reported that the actual number of beginner couples in the Portland area is 1100.

PHILLIP V. RENNICK (Jo) Rogue-Sis-Q. Phil reported that they have gained a club in the area and lost a club.

ART FAUST (Ruby) Sunset. He stated that clubs are still having classes for new dancers but that the problem seems to be that once they start, they begin to drift away. He would welcome any suggestions from anyone whose club has found an answer to this problem.

HOLLIE HEMENWAY Teen Area. She reported that the Teens had not been very busy, except that they had had their Muscular Dystrophy Dance in August. They made approximately \$250.00 and she thanked everyone for their support. She stated that teen area dances will start in January - the third Sunday of every 4th month. They will get more information out.

RON MACKEY (Leita) Three-Valley. He stated that lessons had not been started yet this year but that the entire council would coordinate lessons beginning in January. The council is going the biggest share of advertising and promoting instead of the individual clubs. He stated that they are getting tired of competing with the Eastern Oregon hunting season and for that reason delayed starting lessons. He stated that there had been some discussion about the Eastern Oregon Area and the Three-Valley Area pooling their resources to host a State festival some time in the future.

BYRON STEWART (Trudi) Umpqua (Substituting for Luther Chrisenberry) Byron stated that one thing they had done in his Area to encourage square dancers is that they give some extra lessons after they have graduated. These extra lessons will make the dancers alot smarter but the dancers seem to get discouraged by it. This year, they are not going to hold the additional lessons, until the dancers themselves decide they want or need them. He stated that there is a group taking lessons at Glide and they may form a club and reunite with the Federation. He stated that the Glide Club could use alot of visitors to keep them encouraged.

TEN MINUTE BREAK.

President Chuck reconvened the meeting. A report was heard from TOMMY THOMSON on the Fairview Dance. Tommy reported that the Fairview Dance is the one official dance we have that is entirely of benefit to someone else. Tommy stated that there was a time past when changing of the charity recipient was being considered; however, at the urging of the McKNIGHTS, he took a trip to the cottages and his mind was changed immediately. The Fairview dances are donation dances. There are other ways of raising money for this dance and last year IRENE THOMPSON made an afghan which the club raffled off and made \$155.00 for it. Any projects any club might have to raise money for the Fairview dance cause will be appreciated. He urged the delegates to tell the clubs in their areas about this and urge them to do something about it. This year's callers will be Marty Firstenburg, Randy Dibble and Sam Scott. The Tandem Teens will be the exhibition square. He urged all the dancers to come and bring their money. At this point, BERNICE GRUCHELLA reminded the group that she and GEORGE had purchased a book similar to the History Books and were anxious to get articles, photos or any souvenirs of past Fairview Dances to put in the book.

OLD BUSINESS

ED WARMOTH stated that he had a final report on the past Summer Festival. At the last meeting he gave a report, however there were 1 or 2 items not firm yet. The report indicated that the committee would be approximately \$385. short of paying the final bills. The demonstration groups have now presented the Committee with bills for the day they performed. The Committee had previously said that anybody who put on a demonstration was entitled to free registration on the day they performed. The Committee decided they should pay their registration in advance and then the one day's registration would be refunded. Between the Portland Rainbows and the Stars and Stripes, there is another \$110. due those young people, so the total deficit is \$495. Ed stated that it had been pointed out to him that current Practices and Procedures call for the area council that hosts the dances is to share in the deficit as well as the profit. Of course, they always thought in terms of making money. However, Ed stated that since this had been pointed out, the Portland Area delegate would take back to the area the information that that area now has a bill for \$247.50 as Portland Area's one half of the loss. End of report.

AL WESTPHAL moved that the final report of the Summer Festival for 1976 be accepted and that the Portland Area Council be asked to accept their one-half of the deficit. Motion Seconded by EARL AYERS. Motion was carried.

AL WESTPHAL also stated that there were still some posters available that were purchased by the state to be given to any clubs that wanted them. Bumper Stickers were also discussed and it was noted that by tearing the words that pertained to the Bi-Centennial off the ends, they could still be used. Since we are in the hole on this, it was suggested that they be sold for \$.25 apiece. Since we are \$382. behind on this item, we need to sell as many as we can to help defray this. It was suggested that each delegate take some of them home and try to sell the part that says "SQUARE DANCING, AN AMERICAN HERITAGE".

NEW BUSINESS

President Chuck explained the new Festival Advisory Committee that has been formed. It is made up of the First Vice President, who is state liason officer for the festival by reason of his office. The First Vice President is chairman of the committee, the past president and the last two summer festival chairmen. Each year, the First Vice President will be Chairman. The job of this committee will be to work with areas that want to have a Festival. There are areas who have

not had a Festival at all or have not had one for many years. This committee will come into their area and explain just what a festival involves, how big a job it is and where they can look for help from other areas of the State. The present committee consists of AL WESTPHAL, Chairman, GRAHAM WOOD, JACK BRINSON and ED WARMOTH.

AL WESTPHAL reported that since this is a new committee it did not have much to go on, but that the committee did have an opportunity to go down to Roseburg and work with the Summer Festival Committee there. He stated that there is a good feeling of cooperation among the people in Roseburg and that they are a solid group working for the good of square dancing. In the future, there will be some conditions and rules and guidelines for the committees to work by. Also, the committee has attended Winter Festival committee meetings. It is recognized that the problems of these two groups are entirely different. Al stated that he hopes that some of the guidelines that the committee eventually sets can be incorporated into the Practices and Procedures. If the Eastern Oregon or Three Valley areas want to combine forces to host a summer festival, Al suggested that the matter be tabled until the meeting at the Winter Festival when their bid could be submitted. He also stated that any other areas wishing to host a future summer festival could also submit a bid at the meeting after the Winter Festival and that it might be possible to have the 78, 79 and 80 summer festivals awarded at that time which would give the committees alot of time to work on it.

President Chuck stated that the bid should be in the form of a Letter of Intent which would give basic information such as where the festival would be held and what kind of housing facilities are available, etc.

ACCEPTANCE OF SUMMER FESTIVAL BUDGET The president then asked State Festival Chairman, WARREN ENGDahl, to present the budget for the Summer Festival, for discussion and adoption. Mr. Engdahl presented the budget in detail. A copy of this budget is attached hereto and by reference incorporated herein. It was moved by DON CRAWFORD that this budget be accepted. Motion was seconded by AL WESTPHAL. Motion was adopted.

ERVIN WILLIAMS, President of the Eastern Oregon Area, our Host Area, stated that he would have found it very helpful if he could have had a packet of information provided to him by the State giving them some guidelines for hosting the State meetings, including what the facilities should include, who to send information to, etc. He stated if he had had this, he could probably have saved alot of wear and tear on some of the local dancers as well as had a publicity spread in the paper.

The President acknowledged that this was a fine idea and appointed the Corresponding Secretary to work up such a packet of information for use in the future.

HAROLD BRESSLER, the Mid-Willamette Delegate, again brought up the Legacy program. Ruth & Verne McKnight and Bud and Shirley Parrott have been invited to go back to this program. We sent back to the areas a request for some help for these people going back for these meetings as it is quite expensive. It is for the whole state, not just the Mid-Willamette area. The Mid-Willamette area came up with the thought that the state should, perhaps, contribute some money toward this. Mr. BRESSLER asked for some opinions on this.

VERNE MCKNIGHT at this point stated that he and Ruth had accepted this invitation on their own and that they would like to do this much for Square Dancing in the state, but appreciated the thought very much. At this point RUTH MCKNIGHT explained briefly that the Legacy program started just a few years ago. It consists of about 250 leaders in the United States who are invited to go the meeting. They

are invited to go to this meeting. They are people who have had a responsibility in Square Dancing. In our State, to my knowledge, there were just two that went last year, Bob and Clemme Anderson and Bud and Shirley Parrott. Each year, the people who have gone before invite two more people, so there have been 4 people in the State. The other two are the BARNES and the BARTHS. They have all been from the Mid-Willamette Area. Next year, when we are asked to invite two people, we will try to get them from some other area. There are many things that come out of this meeting. Last year, they worked on the Bi-Centennial. This year, it is going to be in Memphis. Last year, it was in Cleveland. Ruth stated that she and Verne were not asking for any help, that they wanted to do this for Square Dancing in Oregon. She said the Legacy program was just leaders getting together and discussing square dance problems and bringing the information back to the dancers.

There were several expressions of opinion that while Legacy is a very good thing, it is not something that the state should underwrite, as there would likely be no end to it, and it would set a precedent that would be impossible to keep up with.

MOTION TO

MAKE AL WESTPHAL moved that the Festival Advisory Committee be made a permanent part ADVISORY of the Practices and Procedures. Seconded by RAY MURRAY. Motion was adopted.



Therebeing no further business, it was moved and seconded that the meeting adjourn. Motion adopted.

The next meeting will be at the Winter Festival as indicated earlier in these minutes.
