# OREGON FEDERATION OF SQUARE AND ROUND DANCE CLUBS MINUTES OF STATE MEETING HELD NOV. 6, 1977 HIGH SCHOOL, TOLEDO, OREGON

The meeting was called to order at 10:15 by President, AL WESTPHAL. The invocation was given by EARL AYERS; thepledge of allegiance to the flag of the United States was led by RAY MURRAY. President, AL WESTPHAL (FRAN), introduced Area President, GLENN BARBER (MAXINE) and Area Delegate, EARL AYERS (CHAROLETTE). AL thanked the Lincoln-Tillamook Area for hosting the Saturday night dance and arranging the meeting and forth-coming luncheon.

ROLL CALL: All officers and delegates in attendance with the exception of the Puckett's] Teen and Three Valley Area delegates. All newly appointed Goodwill Ambassadors were present except GEORGE & BERNICE GRUCHELLA.

Motion to approve minutes

RAY MURRAY (DOROTHY), First Vice President, moved that the reading of the minutes of the last meeting be dispensed. Motion seconded. Minutes accepted as mailed.

TREASURER'S REPORT was given by GLEN PFEFFERKORN and accepted for audit. A copy is attached hereto and by reference made a part hereof.

# OFFICER REPORTS:

FIRST VICE PRESIDENT - RAY MURRAY (DOROTHY) reported the Summer Festival Advisory Committee met with the Interstate Highlanders Area last month. The Committee will be meeting with the Emerald Empire Area November 19th.

SECOND VICE PRESIDENT, CLINTON BARNES (LUCILE) reported he had approximately thirty-six directories remaining and suggested these directories be sent to the 11 Western States' Federations. He also reported a Round Dance Lab was formed at the last Legacy meeting in Memphis, Tenn. BUD and SHIRLEY PARROTT from Albany, Oregon, were chosen as directors of this Lab.

Motion to send directories to West States PRESIDENT, AL WESTPHAL, stated he thinks it is a good idea to communicate with the other Western states and invited a motion for our corresponding secretary to send our Directory to the ll Western States and ask for their directories in return. BUDDY RANDALL so moved, it was seconded and passed that the directories be sent to the ll Western States, Hawaii and Alaska organizations and ask for their directories in return.

RECORDING SECRETARY - BARBARA WINTERFELD (GEORGE). No report.

CORRESPONDING SECRETARY - BEV NASHOLM (JOHN). No report.

MEMBERSHIP CHAIRMAN - PETE ROTH (DORIS). Pete gave each delegate a letter he had written, inviting them to visit non-federated clubs in their area. He asked that the letter be taken back to the areas, making it public at the area meetings, asking that someone from the area visit the non-federated clubs and invite them to join the Federation, hoping to build up the membership this year:

PAST PRESIDENT - CHUCK McDONALD (HELEN) presented information on the 27th National Square Dance Convention in Oklahoma City. Anyone interested in organizing a tour or wanting additional information should contact Chuck or ED WARMOTH. Being offered is a picture especially painted for square dancers showing square dancing on the plains; it is being sold for \$25.00 per print, to raise money for the Nationals. Only 1,000 prints will be sold, then the plate will be destroyed. Chuck also mentioned the nominating committee for the State Federation will be meeting at Winter Festival in Eugene on January 29th. Four applications have been received, but he is hoping for many more prior to that meeting. Applications should reach Chuck no later than January 15th. The rules have been changed from having only two running for an office to all those applying will be on the ballot.

PRESIDENT, AL, urged anyone interested to please run for an office, if you know anyone who might be interested, urge them to apply so we can have a good list of candidates.

STATE REPORTER - MAXINE REAM. No report.

PRESIDENT AL mentioned LEE REAM is still making progress.

HISTORIAN - EVA MOORE (KEN). Urged the areas to send in any publicity from the local papers, any pictures the clubs may have.

PUBLICITY - BOB INGLIS (DOROTHY). ED WARMOTH has received a letter from the State of Connecticut congratulating us for chosing square dancing as a state dance and asked how this was accomplished. Ed sent all the information we had to Connecticut. A letter was written to President Carter saying that since Square Dance has become our state dance, we feel it should also become a part of the President's Physical Fitness Program. He received a reply from the Director of the Fitness Program which has been given to the Corresponding Secretary. A meeting was held in Portland about a month ago with people interested in publicity, television in particular. investigating the possibility of producing a series for television for educational TV beginning square dancing. A pilot will be shown later in the meeting today. KATU's AM Northwest program has invited any square dance club to become a part of their live audience. Square dancers can bring 15 or more people to the studio to promote or advertise events on the program. Reservations are necessary and those interested may call 231-4610 Monday through Friday for more information.

PRESIDENT AL noted that since Oregon has made Square Dance the official dance, it has opened alot of areas to us.

OFN - RAY SCOFFELD (RAE) Noted people are still sending \$2.50 for subscriptions and the new rate is \$3.00.

SUMMER FESTIVAL - DON CRAWFORD (ROSE MARY). Location of the  $F_{\rm e}$ stival is still not official. The reason it will not be held at Kingsley Field is that it could be pre-empted. They are reasonably sure it will be held at OIT, contract signing is being held up due to the fact a price has not been decided for the use of the facilities. Additional information was given to each officer and delegate.

PASTEPRESIDENT - CHUCK McDONALD added at the last meeting in Kalmath Falls, ERV BLACK brought up the idea of a square dance parade, something like the one held in Pentictin each year; any club wishing can put a float in the parade, bringing the materials from home and putting it together in Klamath Falls. He suggested the clubs begin planning their float.

The January OFN will carry the WINTERFESTIVAL - JERRY FOGELSON (SANDI). program for the Winter Festival. Festival dates are January 28th and 29th with the Trail In Dance on Friday night at Prairie Hall. Callers: Main, Aurora, Colorado and Dick Houlton, Stockton, California; Rounds by Cliff and Ruth Harry of Las Vegas, Nevada. The festival committee is trying to put together a round dance clinic to begin at 8:00 Friday night on international styling to be put on by the Harry's - more information in the January OFN. Saturday morning there will be a caller's clinic held in the willamette Christian Center, upstairs. Downstairs at the same time will be a round dance instructor's clinic. Starting at 10 a.m. on Sat. and Sunday a program featuring Oregon callers (programmed) from different areas of the state, one tip per caller, having 10 to 12 callers on the program. feel this is an important addition to the festival. It is hoped the dancers will attend in large numbers to show the callers our appreciation of them. The Federation meeting will be held on Saturday at noon, rather than Sunday. This will be held in the Willamette Christian Center. Introduction of the State Officers will be on Saturday afternoon between the two major segments of the dance. POOFS will have Sunday morning me-host breakfast from 8:30 to 9:45 at the Heritage Restaurant on 6th & 7th St.

GRAHAM WOOD - FAIRVIEW DANCE CHAIRMAN - (NEDRA) Flyers will be available at Winter Festival. A list of acceptable presents for patients at Fairview was given each delegate and officer. CRAHAM and NEDRA presented CHUCK AND HELEN McDONALD a plaque of appreciation for out-standing service.

Closed circuit TV program of beginning square dancing showed by PAC during coffee break.

# DELEGATE REPORTS

CENTRAL ORECON - ED CRAVES (NELLIE). Area rejected the new insurance plan. The local newspaper prints on Friday evening the square dance activities for the coming week.

EASTERN ORECON - RALPH WALLACE (PEGGE). Reported AL and FRAN WESTPHAL came to their last Area dance.

PRESIDENT AL commented on the excellent report RALPH WALLACE gave to his Area Council regarding the State Meeting. AL again stressed the importance of the communication between the State and the Area and the Clubs.

EMERALD EMPIRE - JIM MILLARD (DORENE). The Area has made no decision regarding the new insurance. Jim presented information about the new Performance Hall at the Fairgrounds plans and picture. The bond issue for this facility is on the Nov. 8th ballot. Completion date for this

building is December 1978 and they are hoping to hold the '79 Winter Festival in the new building. This new building will have dancing area of 48,000 square feet compared to the 12,000 square feet now available.

INTERSTATE HICHLANDERS - DON CRAWFORD (ROSE MARY). Area Council meeting came up with no decision on the new insurance plan. Not enough information available. Ron Telford left Burney and they have hired Jerry Barnes who is new in the area. Alturas has started a new club. Also mentioned for the Summer Festival, if it is held at OIT, will have a level parking lot for RV parking. A sewage truck will service the RV's and National Guard will supply water. Shower facilities will be available in the gym.

LINCOLN-TILLAMOOK AREA - EARL AYERS (CHAROLOTTE). Commended AL AND FRAN WESTPHAL for doing an excellent job in their office. Area seems to have a negative attitude regarding the new insurance.

MID-WILLAMETTE -BOB SAMS (MATTIE). Announced the Spring Meeting hosted by Mid-Willamette Area will be May 20 and 21. More information later.

PORTLAND AREA - JACK BROCK (JOY) Alternate. SPARKLE ALLEN had major surgery last week and she and TOMMY were unable to attend this meeting. Jack reported the educational program at Portland State, teaching square dancing to teachers was very successful with 41 graduates last June. Another class will be offered in January, for eleven weeks, 2 hr 40 minute classes for three credits, Joyce Buzzard will be teacher.

ROGUE SIS-Q - CAL THOMPSON (ARLA). Cal reported there are 500 beginner dancers in the Rogue Sis-Q Area.

SOUTH COAST - VERN LINGARD (EVELYN). No decision on the insurance since they did nothave enough information. Vern presented a resolution requesting the State reduce the number of square dancer's rounds of the month to six per year. Their feeling is that it would make round dancing easier to keep up with for the average square dancer and it would leave round dance clubs time to bring in more advanced level rounds for their enjoyment at their clubs.

SUNSET - ART FAUST (RUBY). Noted AL AND FRAN visited their area. The area believes there are too many loop holes in the new insurance program. Area is having a brush-up class once a week to keep people on their toess and interested in square dancing.

TEEN - no delegate present. PRESIDENT AL requested all areas to contact the teens in their area and find out what their feelings are and if there is anything the federation can do to help them in getting to the state meetings, anything we can do to assist them. We would like to know their feelings if they want to be included in the state as a Teen Area. If they don't the Constitution and By-laws will have to be revised, if they do, we would like to have representation at the meetings.

THREE VALLEY - not present.

UMPQUA - ROBBIE ROBERTSON (WILMA). Had an appreciation dance for the people who worked so hard at Summer Festival, which was a great success. Have good classes going.

#### OLD BUSINESS

BUDDY RANDALL (NANCY) - PARLIAMENTARIAN - Buddy had our insurance agent compare the two insurance programs. The old insurance had no deductible, the new has \$250.00 deductible. The new insurance a claim must be put in within 20 days, our present insurance has a six month limit. The new policy requires 100% participation and present insurance does not. Buddy asked the delegates if they have the present insurance policy information, they did not, so information will be forthcoming.

PRESIDENT AL made a rule of the chair that the new insurance be dropped and that we keep the present insurance.

### NEW BUSINESS

GEORGE PITTELKAU (GENI) - Rose Festival Dance - June 9th, 1978 - Mt. Hood Community College. Caller will be Bob Van Antwerp. More following in the OFN.

GOODWILL AMBASSADORE REPORT - RUTH McKNIGHT remarked that she was glad to see new faces in the new officers, nice to see old ones too. ED WARMOTH reported that Oregon Square Dancers are planning a sister city trip from Portland to Sapporo, Japan in August. ED also read a poem ifrom the current American Square Dance Magazine, "More Fun Than Work".

DOROTHY INGLIS (BOB) presented sewing books that were sold at this year's summer festival, available for sale.

PAST PRESIDENT - CHUCK McDONALD reported that the 1979 Summer Festival Co-Chairman will be GRAHAM AND NEDRA WOOD

PRESIDENT AL stated he would like the film shown at break time investigated and brought back to next meeting. AL appointed BEN SHAFERr as committee chairperson to investigate infromation pertinent to our producing the educational films. BEN explained that the State Library would like films to make available to schools and institutions on beginning square dance lessons.

PRESIDENT AL instructed the Corresponding Secretary to send a card to SPARKLE ALLEN from the Federation, hoping she gets well and back into action soon. AL asked the officers turn in the numbers of stationary they have and stated he thought it time we update our letterhead to include the correct Federation title. He asked the corresponding secretary to consult with BUDDY on this matter.

CHUCK McDONALD asked the new Publicity Chairman to see that OMSI in Portland is supplied with a square dance emblem for their display of Oregon State symbols.

GEORGE WINTERFELD reported on a new law that came into effect on 10-4-77, having to do with bingo games. He suggested any club or area having ideas of bingo that they contact their local District Attorney and ask him of the requirements and qualifications. He noted raffles or lotteries are strictly against the law. Please see the addendum to these minutes for the law.

PAST PRESIDENT - CHUCK McDONALD made a motion the Federation donate \$50.00 to the Tourmament of Roses for the  $S_q$ uare Dance float. Motioned seconded and passed.

On the South Coast's Resolution for having only six round dances for the year, PRESIDENT AL requested this be taken back to the areas for their action. To be brought back at Winter  $F_e$ stival.

JERRY WOODWARD, Caller. is concerned about the "new junk" coming up in square dance calling. Concerned about the length of lessons - running 41 or so weeks. He opposes new gimmick stuff' would like standardization. He would like dances labeled as to what level they are so a dancer knows what to expect when he goes to a dance. He noted a challenge dance can be called with the 50 to 75 basics.

HARCLD VANCE, 49'rs Past President noted Sets in Order had an article on this same subject, wouldlike to see standardization throughout the United States so anyone could dance anywhere, which is difficult to do now.

RUTH McKNIGHT stated she feels the variety is necessary, feels need for the challenge, but agrees the dances should be labeled.

A Motion was made and seconded and the meeting adjourned.

- (1) "Bingo or lotto" means a game, played with cords bearing lines of numbers. in which a player covers or uncovers a number selected from a container, and which is won by a player who is present during the game and who first covers or uncovers the selected numbers in a designated combination, sequence or pattern.
- (d) Bingo or lotto operated by a charitable, fraternal or religious organization when no person other than the organization or player profits in any manner from the operation of the lottery and when the organization has complied with the provisions of subsection (2) and section 2 of the 1977 Act.

As used in this section, "charitable, fraternal or religious organization" means a person organized and existing for chariatble, benevolent, eleemosynary, humane, patriotic, religious, philanthropic, recreational, social, educational, civic, fraternal or other nonprofit purposes, and who is also exempt from payment of federal income taxes because of its charitable, fraternal or religious purposes.

- (5) "Lottery" or "policy" means an unlawful gambling scheme in which:
  - (a) The players pay or agree to pay something of value for chances, represented and differentiated by numbers or by combinations of numbers or by some other medium, one or more of which chances are to be designated the winning ones;
  - (b) The winning chances are to be determined by a drawing or some other method;
  - (c) The holders of the winning chances are to receive something of value.

# SECTION (2) par. (2)

Prior to its commencement of operation of bingo ot lotto, an organization shall notify the Corporation Commissioner of its proposed operation and shall supply a certification of its exemption from payment of federal income taxes as a charitabl fraternal or religious organization. No further ntification to the Corporation Commissioner shall be required unless the organization has lost its tax exempt stat or unless the organization resumes the operation of bingo or lotto after having ceased such an operation for a period of three years.

The bommittee for the Summmer Festival 178 met Sun. Morning, Oct. 16, to view the campus at O.T.T. as a possible site for the dance. The change of site for the dance is felt to be necessary as the Covt. has not too many new restrictions on their frem offer of the airbase.

Those present were: Murrays, Brinsons, & McDonalds, State advisory committee, Blacks, Chairman; Crawfords, co-chairman; Scotts, Treas.; Puters, Sec; Hazel Kramer, Registration; Emmett Culpepper, Style show; Staehnkes, Round dance; Clodowskis, Printers; Shirley Mayhew, Perry Mixer's rep.; Casads, Tule Twirler's, rep.; and Bloss's Toketee Cascaders, rep. They all met with Fr. Erickson and Caroline Kramer Public Relations from O.T.T. Friekson said quote, "The college is excited about having the Square dancers" July 18:14-15-16.178.

There are ample restrooms and shower facilities in the P.W. bld;

Owens hall will be ideal for commercial booths. They will rent 15 rooms, some can be set-up as early as noon on Thurs. and the rest by 4:30. There is no school on Friday.

They can house 400 people on the grounds fromm 5 to 6 per room The comm. will pay for MOn-dancing chaperones.

Emmett Culpepper was assured the use of the auditorium for the style show.

For registrations, it was suggested that a trailor house be placed in the parking area at the entrance of the campus, with a sign, All Square Dancers Stop Here, This includes all local dancers too, as we want an accurate count.

Parking attendants will obtained from some service organization.

They will consult the hospital, which is next to the O.T.T campus, about possible First Aid Services.

Frv. Black assured the adv. committee that the Festival come will have everything ready to go by the Winter Festival, the 4th weel-Qend in Jan.

The next meeting of the Summer Festival'78 corm. will be at JOJI's Hettaurant, adjacent to Payless in Town and Co. Shoppin; center, Same Nov. 27, at horclock as Erv. has classes in the evening.
