#1. THE PRESIDENT ELECT IN COOPERATION WITH OTHER ELECTED OFFICERS AND STANDING COMMITTEE CHAIRPERSONS, SHALL PREPARE A STATEMENT OF GOALS AND A BUDGET TO SHOW HOW MONIES ARE TO BE RAISED AND SPENT. THE GOALS AND BUDGET WILL BE PREPARED AND SUBMITTED TO THE EXECUTIVE BOARD AT THE SUMMER FESTIVAL MEETING FOR REVIEW AND RESUDMITTED FOR ACCEPTANCE AT THE INSTALLATION MEETING.

#2. ALL CHAIRPERSONS OF DESIGNATED SPOKESPERSON OF ANY STATE SPONSORED DR CO-SPONSORED FUNCTION SHALL PRESENT A DETAILED WRITTEN REPORT, INCLUDING A FINACIAL STATEMENT AT EACH STATE MEETING HELD AFTER NEGOTIATIONS FOR CONTRACTUAL ASSISTANCE AND FACILITIES BEGIN. FROM: The Round of The Month Screening Committee TO: Oregon State Area Presidents and Delegates Subject: Explanatory Letter.

The round of the month screening committee developed as a result of a resolution passed during the State Federation meeting in Eugene at the Winter Festival 1980. The main goal of the resolution was to <u>aid</u> areas in selecting rounds of the month. The committee that screens and recommends dances for round of the month is comprised of both round dance teachers and square dance callers. Committee members are:

Tom & Ida Serface, Hermiston-- Koko & Gordon Sutton, Portland--Gene & Lois Noble, Portland (Caller & R/D Teacher) - Slick & Melba Fox, Bend(Caller) Bud & Shirley Parrott, Albany-- Ward & Joyce Foster, Montague, Calif. This couple teaches in Oregon and was elected by the Southern Oregon Round Dance Teachers Assn. Lloyd & Elise Ward, Eugene(Chairman).

Committee members have geographical distribution throughout the state and can be easily contacted by many dancers. They are all well qualified and very interested in providing a good selection of rounds for Oregon dancers. An explanation of how the committee works. Each member sends to the chairman a list of dances they feel are good ROM's, that meet the existing guidelines. The chairman compiles a master list of the dances recommended by the committee. Using a simple mathematical method the dances are rated in numerical order. This master list and instructions are sent to areas well in advance of selection deadlines. It should be clear to areas, that dances selected for presentation as possible ROM' are the result of collective thinking of the committee and <u>not</u> just the thinking of one person.

Dancers, callers or teachers who know of round dances they think would be good rounds of the month are urged to contact the nearest committee member. The resolution stated that a list of rounds would be provided for the areas and that areas would select a round from the list. Areas or dancers are not required to teach or learn any of the dances selected.

Experience to date indicates that areas are cooperating and are selecting good rounds of the month. Areas will select ROM's according to the list printed in OFN. When your area selects the round, notify these two people as soon as possible.
