Note: A festival income history for the past eleven years shows an average income of \$2,229.00. \$500.00 loans were given to Festival committees until the year 1975 at which time \$1,000.00 loans were given. The need for another increase in loans is apparent in light of the economy and inflation.

An analysis of mileage and motel for the past fiscal year showed that the current rate of a maximum of \$25.00 for motel and 20¢ a mile for travel one way will cost the Federation an additional \$1,930.00 over the \$13.00 motel and 13¢ a mile travel one way. By comparison, the \$18.00 for motel and 15¢ a mile travel one way as proposed by the Constitution and By-Laws committee will cost the Federation an additional \$1,253.00.
