Minutes of State Me-ting held May 6, 1984 Grant Union High School, John Day, Oregon

Meeting was called to order by President, Ed Warmoth, at 9:35 a.m. Invocation was given by Past President, Vern Meyer. The Flag salute was led by Second Vice President, Floyd Bard.

All officers and delegates were present except Robert Lohman, Parliamentarian & Insurance Rep; Leonard Bacon, Publicity & State Reporter; Central Oregon Area Delegate, Bill & Iva Welsh, Bob & Jeanne Yancey, substituting; Emerald Empire Del. Leon & Pat Houle, Jim & Boots Floyd, substituting; Rogue Siskiyou Area, Frances Pence, Phil Rennick, substituting

Am bassadors absent were Wayne & Georgia Puckett, George & Berniece Gruchalla, Vern & Ruth McKnight, Al & Caddie Boyer & Bud & Shirley Parrott.

Motion made by Second Vice President Floyd Bard, that the minutes be accepted as mailed. Motion seconded & carried.

Jeam Brigl, Fianancial advisor requested a correction to the minutes in re Financial Advisors report, Page 5, i.e. "Please inform your clubs that they need not be concerned with operating within requirements" to read "Please inform your clubs that they <u>do need</u> to be concerned with operating within requirements of non-profit status organizations". Jean again offered her help to any of the clubs needing it in re this non-profit status matter.

President, Ed Warmoth, here excused the nominating committee consisting of; Vern Meyer, Chrmn., Al & Fran Westphal, Ray & Dorothy Murray and Buddy Randall to count the ballots. A total of 148 ballots were sent out and 121 returned to the Recording Se cretary completed and 6 were returned as undeliverable.

Financial report was given by Treasurer, Carolyn Pape. Copies were distributed to all Officers and Delegates. A copy is attached hereto and made a part hereof. There has been little change in the report and we have essentially the same amount of cash carryover. It is advisable that the bond required for the Treasurer's position be up-dated. Motion made that the Treasuer's bond be increased from \$2000 to \$20,000. The increased fee would be \$101. instead of \$46 previously charged. Motion seconded & carried. Carolyn also requested that when you make out your check for especial funds such as the "Statue of Liberty Fund" you make the check to the Oregon Federation and indicate in the lower left corner which fund it is to go to. This will make dealing with the bank less complicated.

#### OFFICERS REPORTS

<u>President, Ed Warmoth,</u> reported that he and Mary have received a very special invitation to all of the Oregon Dancers from the Premier of British Columbia, to attend the Penticton Jamboree. Ed & Mary will be staying at the Delta Lakeside and would hope that any Oregon dancers who need to rest their feet would stop by and see them. Thursday evening of Jamboree week we will have an opportunity to do something special at the dance intermission to feature the state of Oregon. and we hope to havean Oregon float in the parade. Mary & Ed have visited eight Area Council meeting; and will visit with the Eastern Oregon Council at the end of June. Hope to go to the Washington State Meeting in Vancouver. Will be going to the Washington State Festival, Oregon State Festival, Diamond Lake and Penticton.

Past President, Vern Meyer. No report, will report on outcome of election later.

First Vice President, Jack & Rosemary Williams, visited a Portland Area Council Meeting in February and gave the Festival Chairman '86, Bill Bradshaw, a copy of the Festival Guidelines. March 19, we visited '84 Festival Committee in Salem and tried to answer any questions that they had. Attended their Area Council Meeting and was really impressed with the attendance and the support of their group. Sent a letter of inquiry to Mac & Mary McClure re a National Movement of Support by dancers of the Statue of Liberty Restoration Fund. He received a reply from them stating that they thought the idea an excellent one and they would be attending a National Square Dancers Leadership Seminar in May where they would read Jack's letter and were sure there would be some positive response and support of the idea.

Second Vice President, Floyd & Jill Bard, has submitted receipts for sales of '83-'84 Directories of \$44.00 sold at the '84 Md-Winter. We printed 2300 Directories at a cost of \$1816. Sold approximately 2100 of them for \$1794. Sjprt \$22. Would recommend that we print same number of directories for 1984-'85 for a budget amount of \$1900. Would like to make some changes in the Directories: Print prodeedures in the directory and Oregon Federation News how and whom to notify of name and address changes during the year: Index by club, with a black quick index on edge of pages such as on a dictionary; Alphabetic listing of State callers and cuers' Continue major dance section, but also list of dates of special dances, including dances for Areas; Print a calendar from September thru December of the following year; Accurate indication of level-of-dance in directory and Where & When in OFN; Use Federation Logo on front cover with year & divide back cover for advertising both State Festivals.; Also include whether a club does or does not dance during the Summer. We have revamped the club membership application forms and all of this information I have suggested can be included on this form if it is properly filled out.

Treasurer, Carolyn & John Pape, No further report at this time. Be sure and turn in your blue slips if you wish to be paid.

Recording Secretary, Buzz & Glenore Carrier, No report - but would like to thank the Blue Mountain Area for a great week-end.

<u>Corresponding Secretary, Janet Pederson</u>, Sent out 148 ballots and 121 were returned. It was necessary to change the ballot mailing to Club Presidents rather than club Secretaries as many clubs did not have Secretary addresses listed. Would like to thank Floyd Bard for all the labels (1200) that were required for balloting process. This was most helpful. Be sure and give me badge infor for new Delegates and other Officers so that I can have the new State badges made up.

Membership Chairman, Bob & Barbara Brown, reported good news & bad news. Interstate Highlander Council is to be congratulated for the 100% return of club info for the '84-'85 directories. Delegates please urge your clubs to get this information to us promptly. Clubs must fill out 3 copies of membership application of forward to the Council Secty. who keeps one copy and sends us two. We have lost 2 clubs, The Flying Eagles, Mid-Willamette and Square Knots of Tualatin Valley Council. Good news- we have an application from Red Garter Squares f Mid-Willamette Area. Everything is in order. Motion made, seconded and carried that they be accepted into the Federation. We have application from the Promenaders, Portland Area Council, All is in order. Motion made seconded and carried that the Promenaders be accepted into the Federation.

President, Ed Warmoth reported on a suggestion presented by Bob BrowAthat this organization adopt a membership certificate which would be issued to each club with membership in the Oregon Federation and that each year, upon payment of required dues, they be issued a seal or stamp of some kind that could be added to the certificate. This could then be posted on the bulleting board or somewhere in the hall and would be tangible evidence to club members of membership in the State Organization.

Financial Advisor, Jean & Hank Brigl, Thanks to the Blue Mountain Area for a good time. An ad hoc committee headed by JackWilliams for the Oregon Federation News met Saturday afternoon to discuss alternate means of continuing the newsworthy articles in the OFN and yet keep the OFN Fund in balance. Jack will have a full report of the current feelings of this committee. In regard to the non-profit and tax exempt status of clubs, Hank & I have been working very closely with clubs- 37 of them up to this time - by phone, by mail and by visiting the clubs and/or their appointed person/s who are working on the non-profit status for their clubs.All clubs recognize the benefits of incorporating as non-profit and are doing so if they are not already non-profit. However, we are finding that the majority of clubs who do not have their tax exempt status are finding it difficult to meet the 15/35% unrelated income requirement. Communications with Senators Packwood, Hatifield, Congressman Weaver and Governor Atiyeh have been instituted to make them aware of the futility of square dance clubs meeting the tax exempt codes of the IRS and the cost to the government in processing the tax returns of clubs where the tax revenue is not enough to pay for the paper the forms are printed on, much less IRS staff time to do the processing. Ed Warmoth has also written a letter to Senator Packwood witha reply from the IRS referring only to their rulings. Our endeavor is to; (1) Confer with the IRS on the premise that if organigations with a specific activity such as square dancing who are ll meeting with a specific purpose so stated in their constitutions, and that purpose is or commingling and encouraging and promoting the very activity for their being, then the commingling of these persons shall be considered as one body and the non-member ruling for the use of a facility or services shall not prevail. If the IRS is unable to give us a blanket ruling then our next step will be (2) Initiate legislation to institute a separate tax exempt code for squre dancers the same as there is now for other organizations (i.e. " Group Legal Services", "Black Lung Benefit Trusts', "Title Holding Corporations", "Cemetery Companies", etc.) allowing the commingling of all groups with a specified like purpose, with no restrictions on public promotion for meembership, to achieve that purpose. Knowing that many clubs will not meet the15/35% ruling, please ask your clubs who are working on tax exemption to contact me by mail,or phone before completing application to the Internal Revenue Service. 345-0916 eves. or weekends.

Norm Anderson reported that he has been having a great deal of problem getting the forms filled out to suit IRS. Jean will give guide lige packets to those clubs having problems.

President, Ed, stated that we are trying to conform but feels that some of these requirements do not exactly fit the square dance organizations, and would suggest that we keep in touch with our Congressmen in hope that an understanding of the unique situation of our square dance organization will be forthcoming. Bob Brown presented a listing of total club count by area. We have 10,264 dancers in Oregon and as a board we represent those dancers.

Parliamentarian and Insurance, Bob & Harriet Lohman, Absent. President, Ed Warmoth reported on contact he has had with Bob Hodgins of Eugene Insurance Agency. As of 5-4-'84 there were 42 clubs signed up for liability and 12 callers and 9 clubs signed for accident 'nsurance totalling 629 people in those 9 clubs. Last year there were considerably more clubs signed up for this insurance. The Eugene Insurance Agency is trying to cooperate and have no plans to change insurance coverage for this year. An Insurance Committee will be meeting at Harold Bressler's next Saturday, May 12. They are working on an Insurance program for next year. Insurance should probably be a club service, i.e. club dues to include insurance and Oregon Federation News.

<u>Publicity & State Reporter, Leonard & Charlene Bacon, Absent.</u> President, Ed Warmoth, stated that Leonard has up-dated the little visitors pamphlet and has presented a report titled "Evaluation of Promotional Practices" see copy of this report enclosed herewith.

State Historian, Trudy & Leonard Rasmussen, Please examine our display today. We are fortunate to have as a new dancer-student the famous portrait painter, Gene Anthony, who has painted many portraits of callers. He has made a wonderful offer to our club. He will be happy to paint a \$350. portrait which includes fram for \$100. for anyone interested. He will then donate \$50. of the \$100.fee to the Buckeroos for a new roof on the Barn. Anyone can avail themselves of this offer and it would be a nice gift. Does not necessarily have to be a caller portrait, can be a Grandaughter or favorite niece or anyone you feel is especial. We will be going to the National in Baltimore and taking a display for the showcase of ideas there. Would like suggestions from any or all as to what should be included.

Education Chairman, Ken & Eva Moore, These Blue Mountains surely did look white this morning!! We have been working with the Mid-Willamette Area re a Leadership Seminar which is set for April 1985. There will be a full report on this later in the meeting. The Educationsal booth at Mid-Winter Festival seemed to be successful so we are planning for such a booth at the Summer Festival. If anyone has educational hand-out material regarding square danceing please get it to me and we will make copies and include them in our display.

Total Receipts were \$32,794.29, After expenses the amount was \$9941. and after Insurance bill there was \$8091 to divide between the State and the Council. Am presenting a check to the State in the amount of \$4045.

All facilities are free with exception of the dorm rooms. Saves our budget approx. \$3000. Callers will be : Thurs. night-local plus other Oregon callers; Fri. Oregon callers plus two featured callers for workshops & dances; Sat. night Oregon callers plus two featured callers for workshops and dances. Callers will be Dale Casseday, Greeley Colo.& Mesa, Ariz. & Bob Baier of Missouri City, Tx. Have not signed the featured round dance cuers yet. Will have an after party chaired by Margaret Bortne and Vera Maddox is in charge of Promotional costumes. Would especially like to thank Bill Cook for his excellent records from the 1983 Festival. Because of those records we were immediately able to establish needs and goals and all committees needed.

President, Ed Warmoth pointed out that we are in good form as far as Festivals. with '85 in Central Ore., '86 in Portland, '87 in Roseburg & '88 in Eastern Ore.

<u>1987 Summer Festival</u> Chuck Rosebraugh had briefly reported on this previously and stated that they are working on a budget and sound.

1988 Summer Festival George Griffith, agreed that the Council had voted to host a State Festival and it will probably be held at Pendleton in a new school building there.

Neglected item of Old Business- Statue of Liberty Restoration Funds, Chaired & reported on by Norm Anderson of Tillamook. Have had a lot of help from Ed & Floyd Bard in putting this project together. Anyone who wishes may donate more than \$10 & if you donate \$15 or more you will receive a certificate for your donation.

Back to New Business - Trudy & Leonard Rasmussen will work up an Oregon display at the National Square Dance Convention in Baltimore. Genevieve Churchill will also be attending and has been invited to represent Oregon in an especial flag scremony at Ft. McHenry.

Resolution was presented from the Tualatin Valley Council by Bill Cook - That three regula meetings be scheduled annually. That two 1 hour meetings be held annually subject to following guide lines: A. Mid-Winter Festival-Present only nominating committee report any other necessary report. B. Summer Festival - State Fair Report - any other necessary report. C. Parliamentarian to move for closing of meeting at the end of one hour maximum. All reports except those called by the President as necessary, to be in writing at the Festival meetings. D. Written agenda listing required oral reports to be mailed or publish in the OFN. After discussion a motion was made to limit Festival meetings to only the immediate and required business. Motion seconded and carried.

FINANCIAL ADVISOR'S REPORT

MAY 6, 1984 JOHN DAY MEETING

An ad hoc committee headed by Jack Williams for the Oregon Federation News met Saturday afternoon to discuss alternate means of continuing the news-worthy articles in the OFN and yet keep the OFN Fund in balance. Jack will have a full report of the recommendations of the committee.

Regarding the non-profit and tax exempt status of clubs, Hank and I have been working very closely with clubs - 37 of them up to this time - by phone, by mail, and by visiting the clubs and/or their appointed person/s who are working on the non-profit status for their clubs.

All clubs recognize the benefits of incorporating as non-profit and are doing so if they are not already non-profit. However, we are finding that the majority of clubs who do not have their tax exempt status are finding it difficult to meet the 15/35% unrelated income requirement.

Communications with Senators Packwood, Hatfield, Congressman Weaver, and Governor Vic Atiyeh have been instituted to make them aware of the futility of the inability ofsquare dance clubs to meet the tax exempt codes of the Internal Revenue Service and the cost to the government in processing the tax returns of clubs where the tax revenue is not enough to pay for the paper the forms are printed on, much less IRS staff time to do the processing.

Ed Warmoth has also written a letter to Senator Packwood with a reply from the IRS referring only to their rulings,

Our endeavor is to

1. Confer with the IRS on the premise that if organizations with a specific activity such as square dancing who are all meeting with a specific purpose so stated in their constitutions, and that purpose is for commingling and encouraging or promoting the very activity for their being, then the commingling of these persons shall be considered as one body and the the non-member ruling for the use of a facility or services shall not prevail.

If the IRS is unable to give us a blanket ruling then our next step will be

2. Initiate legislation to institute a separate tax exempt code for square dancers the same as there is now for other organizatations (i.e. "Group Legal Services", "Black Lung Benefit Trusts", "Title Holding Corporations", "Cemetary Companies", etc) allowing the commingling of all groups with a specified like purpose, with no restrictions on public promotion for membership, to achieve that purpose.

Knowing that many clubs will not meet the 15/35% ruling, please ask your clubs who are working on tax exemption to contact me by mail or phone before completing application to the Internal Revenue Service. 345-0916 eves. or week-ends.

Report for State Meeting, May 6, 1984

Plans for the Summer Festival are proceeding on schedule. At this time we have 3/0 registrations, 90 who will occupy dorm rooms, and 5/ RV places taken. Motels are filling up fast. Important dates: Pre-registration cut-off date -June 15; Dorm cancellation date - July 13. RV Parking is ample - all of Gill Coliseum lot, but no hook-ups. Showers will be available in Gill for RVers to use.

The sale of advertising is complete with a \$500 income - \$100 over the budgeted figure.

There have been 16 Commercial Booths rented, and 14 have paid their fee. None are from out-of-state. We are phoning others who have shown an interest within Oregon, but are not actively soliciting any from out-of-state, since we got some negative feed-back at hid-winter. However, the committee adopted a policy that we would not refuse any from outside Oregon who wished to be included and paid their fee.

You have seen the preliminary program that was distributed at Mid-Winter. The final program is now being prepared, and a complete dance program with callers listed is attached to this report. We have 45 callers signed up, and each of them will call at least one tip. So far there are 18 cuers signed up for round dancing, and we should have a total of 30 to complete the round dance program.

You have probably seen the articles in the OFN. There will be two more published - in June and July, and they will talk about the dance program and its content. Advertising is being purchased in Footnotes and <u>Swing Your Partner</u> - <u>Where</u> in Washington and <u>The Prompter</u> in the San Francisco Bay Area.

The bus tours from Seattle and San Francisco have received casual response, but there is considerable interest in the Festival in both areas. Our representatives there say that we may attract a number of people to vacation in Oregon and attend our festival while here. So this is better for Oregon's economy.

A copy of an abbreviated budget is attached, and it shows that we are substantially on budget so far, with \$3923 in the bank as of Mayl, 1984. I will not read the budget, but it is available for review for anyone who is interested.

I am waiting for a response from RAZ Transportation Company about providing bus service during the festival. I expected to hear from them before this meeting, but no word by Friday, May  $\mu$ . The extent of the service they may provide is yet to be negotiated.

Sound will be provided by Clyde Charters with help from Andy Culwell and Steve Johnson. We are making every effort to have excellent sound. I have danced in each of the major rooms in which we will dance, and I think the sound will be fine.

We must provide insurance for damage to any part of the facility, and I must arrange this with Buddy Randall.

The Oregon Heritage Festival will be going on at the same time as our festival - from July 16 thru August 11. I met with their organizers, and we are working out an entertainment showing the history of square dancing at one of their events. Bob Erny is arranging this, but the exact time and place have not yet been set.

The Lid-Willamette Area will sponsor a Trail End Dance at OSU on July 19. MS will be in the Lemorial Union Ballroom ans rlus in the Women's Gym. This is not part of the Festival package. An A-Level Trail In Dance is being arranged for Salem sponsored by Good Times. More on these will be out in the future, but not advertized by the Festival.

I notice that an item of new business later in the meeting will discuss future State Festivals. I think it is appropriate for you to set some standards and policies for future festivals. Some of the subjects to consider should be: the inclusion of out-of-state vendors; the levels of square and round dancing to be offerred and taught and the minimum number of hours of each; the expenses for feature callers and cuers; free registration for participating callers and cuers; and how to return any profit from a festival to the dancers in general.

I will see you in Corvallis on July 20, 21, & 22!
