MINUTES OF STATE MEETING HELD MAY 15, 1994
MILTON-FREEWATER

At 9:35 a.m. State President Benjamin Brown called the meeting to order. Invocation with a special prayer for Past President and 1994 National Chairman Don White as he undergoes heart surgery was given by Past President Janet Wilken. Rex Anderson, First Vice President led the flag salute.

All elected and appointed officers were present, with the exception of Financial Advisor Jean & Hank Brigl and Parliamentarian Lee & Barbi Ashwill (Del Fleming subs.). Active Goodwill Ambassadors Don & Shirley White were also absent.

Minutes were approved as mailed.

PRESIDENT BENJAMIN & PENNY BROWN asked for special prayers for Don White. Introduced were members from the Washington State Federation; Donzella & Bill Leahy, Past State President, Ken & Hazel Pomraning, Vice President and Urban Jenquin & Laura Ebner, chairpersons of 1994 State Festival.

FIRST VICE PRESIDENT REX & SYLVIA ANDERSON thanked the Eastern Oregon Area for hosting this State Meeting and the potluck and dance last evening.

1994 Mid-Winter Festival-Del & Sheila Fleming. Official count at Mid-Winter 94 was 3470. Check to 94 National of \$3470 brings to them a total of \$15,186 (over a 4 year period). Insurance check was for \$1735 and Oregon Federation's check was for \$6065.98. An anonymous letter was printed in the OFN regarding the location of new dancers. Recommendation is that the OFN adopt a policy of not printing anonymous letters.

1995 Mid-Winter Festival-Dave & Betty Cameron. Committees are in place and featured persons are hired. We had more volunteers than jobs!! Ribbons will be sold through mail-in or handed-in registrations only. No packets. Get your registrations in early.

1995 Summer Festival-Janet & Doug Wilken. Kickoff Dance is Aug. 7, 2 to 5, with Richard Lane from Mesa Arizona calling and Ray & Virginia Walz cueing. Festival will feature Randy Dougherty, Grand Rapids, Minnesota, and Oregon callers.

1996 Summer Festival. Nancy Morrissey moved the Lincoln-Tillamook Council host the 1996 Summer Festival contingent upon approval of a location by the Festival Advisory Board. Janet Wilken seconded the motion. Passed.

Suggest a drive for subscriptions be at some State Meeting Dance. Rex Anderson moved approval be given to purchase an additional 6.2 Dos Microsoft costing up to \$129, out of the OFN budget. Rex Bounds seconded the motion. Passed.

SECOND VICE PRESIDENT LOWELL & DONNA CHAMBERLIN notes delegates have a memo about directory information. Cost should be \$1.50. Bring monies and pick up directories at next State Meeting.

RECORDING SECRETARY CATHERINE & MATTLON HICKS notes that policy questions need to go to State President but she will research any information she can.

CORRESPONDING SECRETARY NANCY & KEN CARSON mailed ballots, thank you letters and get well and sympathy cards. Thanks to Duane Evar for new name plate holders. A file will be provided for flyers and other information regarding the State Meeting to be placed in-Saturday evening. This is to help cut down on paper shuffling at meetings. 128 ballots were sent out with 105 returned. A letter was read from USDA asking for nominations for officers. Because of the time frame of notification of need for delegates President Brown appointed Ralph & Linda Lambert and Gary & Carolyn Smith to attend the meeting.

Doug Wilken, Don Morris, Carolyn Smith and Rosemary Williams were excused to count ballots.

mtn TREASURER CAROLYN & JOHN FAPE asks that expenses be turned in as soon as they are incurred, instead of accumulating them for some time. We are under budget on OFN. Year to Date profit is \$5608.73. 78% is paid by advertizing and cost per page is \$73.40. Need to be working on your budgets for State Fair, Trailers, Leadership Seminars and Fairview. Printing is high because of unexpected printing of Constitution and By-Laws. Would like to put some of our money in a CD to get a little more interest. I have a copy of the spring issue of Legacy. Catherine Hicks moved the treasurer's report be accepted as presented. Dorothy Daggett seconded the motion. Passed.

MEMBERSHIP TONY & LOLA ROBELLO. Information is slow in coming in for directoies from clubs and councils. Letter has been sent to each with the correct fee information for when and where.

PAST PRESIDENT JANET & DOUG WILKEN express thanks to all dancers, clubs and councils that donated money to help us acheive our goal of \$2150 for purchase of a sound system for background music for the snack bar. 20 squares danced to Jim & Joyce Voll and helped us exceed our goal. A thank you letter was read from Fairview. Also read was a letter regarding clarification of the purpose of the Fairview Dance and the plans made for the operation of such.

Parliamentarian-Lee & Barbi Ashwill (Del & Sheila Fleming subs.). No report.

Publicity & State Reporter-Ed & Mary Warmoth. Next article in OFN will be calling attention to the importance of your delegates and their information. Articles have been published in National Square Dance Magazine and May/June California Square Dance Blue Book. It will help if Square Dance Signs are out welcoming dancers traveling to National, especially for Trails-in Dances.

Financial Advisor-Jean & Hank Brigl. Absent-but reports the 1993 tax return is filed and Federation Books have been audited and are in excellent order. Financial budgets and statements are to be submitted to president, treasurer and financial advisor at each meeting. All incorporated clubs and councils need to verify their current annual registration with the Oregon Corporate Commissioner's office. Your non-profit status, current corporate documentation and/or IRS tax exempt number, 1.E. 501 (c) (--), is required information to be included on the annual Federation registration form.

Education-Doug & Stacey Pederson. Education material from USDA (approval of purchase at Nov. meeting) has been distributed. Remember the training session for new officers is at Sept. meeting. A poem by Stacey Pederson published in March OFN has also been published in The Caller (Memphis) and others. License plate project is still on hold at Salem. I will be a part of Washington State Festival Leadership Seminar at Ellensburg.

Historian-Lou & Evelyn Benjamin. To make our historian books interesting we need pictures and articles from EACH AREA with identification of those in the picture and the event. We especially need material from areas other than "the valley".

Insurance-Gary & Carolyn Smith. 2 injuries were reported since last meeting. Remember to keep records with me updated with names, addresses and phone numbers of new members. Refund from USDA has been received for overpayment. We are still waiting on quotes of prospective policies. Quotes available were read, with discussion of admitted and non-admitted companies. Our premium payment is lost if we are insured by a non-admitted company that goes bankrupt. Catherine Hicks moved the insurance report be accepted. Dorothy Daggett seconded the motion. Passed.

BMI/ASCAP-Ralph & Linda Lambert. Due to the fact that the Federation will have no summer festival this year, the next reportable event will be the 1995 Mid-Winter Festival.

1994 National-Don & Shirley White. Absent. Information has been covered in other reports.

Youth Activities Coordinator-Sandra & Richard Finch. Absent. No report submitted.

State Fair-Ken & Ardelle Wolf. Schedule will be each evening, 8-10, except for Aug. 31. We had over 800 Square Dancers perform last year so get your registrations in early. This is a great opportunity to promote beginning Square Dance Lessons for Sept. through out the State and is quite successful.

State Trailer Coordinator-Jim & Avis Kincaid. Absent.

ORDTA-Ray & Virginia Walz. ORDTA does not receive mileage or other reimbursement for State Meetings but are happy to be affiliated with the Federation.

Round Dance Screening-John & Hope Anderberg. Absent. No report on ROM selections. Resignation is submitted effective Sept. 1.

Delegate Report-Linda & Bob Holden. Candidates need to have more exposure in ALL areas before elections. More dancers need to take the OFN for information about this and also other things. A better method of registering for reservations for RV parking for Mid-Winter needs to be looked into.

Rex Anderson moved these housekeeping changes be approved. Lowell Chamberlin seconded. Passed.

Items of Discussion

Meeting of May 15, 1994

I. Injury Report:

Leslie Schaffer of the Sunset Promenaders was injured in an accident at the Windy Whirlers regularly scheduled dance on Feb 12, 1994. There was some delay in getting the papers filed, but we were able to get her covered. Also, one of the Ladies at the Tigard 59'rs Anniversary Dance on May 7, 1994 was injured when she slipped and was about to fall. Someone grabbed her arm to help her but inadvertently pulled her arm out of the socket. She was taken to Emergency and I haven't had a complete report yet.

II. Coverage Report:

All clubs are insured but we need to be sure to update our records for all clubs that have taken in new members or graduated a class recently. I need to have the names, addresses, and phone numbers of the new members.

I have received a refund from the National USDA office for the ten cents per member too much that we paid earlier due to my misunderstanding of the terms of the agreement. Also we received a refund of \$215.10 which is what we overpaid for Emerald Empire to USDA. We now owe Emerald Empire a refund of \$20.00 that they overpaid us. That is if my figures are correct. I will verify that with Carolyn Pape.

III. Insurance committee report:

The Insurance Committee has not been able to meet for a couple of reasons. 1. The companys who were to provide quotes on the new prospective policies did not do so. 2. We all found ourselves overly busy with NSDC business.

I have received two quotes now, one as late as Friday evening, they are as follows:

My concern is that our clubs are sponsoring events such as beach trips, campouts, and play days of different types which are not covered under our current policy. They have some liability and if someone were to get seriously hurt they are not covered for any medical expenses they might incur. The insurance committee felt that we are a dance oriented organization and we should not try to cover all of these other possible pitfalls, but that does not relieve the liability.

This Report is respectfully submitted to the Board and Delegates for review and consideration on your part.
